**IMPORTANT REMINDERS**

- A. Taxpayer/Owner issued with Temporary Clearances from local agencies is advised to secure the clearances within the time stated in the Temporary Clearances to avoid outright cancellation / revocation of this Permit.
- B. The business establishment is subject to inspection by the Joint Inspection Team to ensure compliance to laws and regulations (zoning, fire safety, environment and health regulations, building and occupancy measures, NGAs regulations, etc.)
- C. If the Taxpayer/Owner desires to continue his/her business operation, the following must be observed:
  1. If the tax due is paid by quarter or semi-annual for the current year, the tax due for the next quarter or period must be paid prior to deadline to avoid application of interest and surcharge.
  2. Permit must be immediately renewed on or before January 20 of the following year unless sooner revoked for violation of existing laws and conditions under this Permit. Otherwise, the Taxpayer/Owner must apply for retirement/cancellation of the business prior to said deadline to avoid imposition of 25% surcharge to the original amount of tax due and 2% interest for every month from the date it is due until paid.
- D. This Permit along with other Clearances must be posted in the establishment to avoid imposition of P1,000.00 for non-posting in accordance with Chapter III, Article A, Section 79 (c) of Ordinance 98-2016.
- E. Payment of Tax due is not equivalent to registration in the City's Business registry. The Taxpayer/Owner must secure the issuance of a Permit Card to secure its corresponding Permit/License Permit Number. Failure to secure Permit Card is equivalent to NO PERMIT, and subsequent penalties will be accordingly applied.
- F. Taxpayer/Owner is advised to read the aforementioned conditions and its legal basis (back of this Permit) for information and guidance.
